#### 2. Presentation

- a. Topic: Using EAIP as a Safety Professional to move your Safety Initiatives
- b. Presenter: Aubrey Sakaguchi, Benchmade Knife Company's EHS professional
- c. Description:
  - i. Every EHS professional knows that workers' comp claims are not the highlight of the job. But the State of Oregon has a unique program to help make good things come from injuries. Join Aubrey Sakaguchi, Benchmade Knife Company's EHS professional at looking at how the knife manufacturer has utilized the Employer at Injury Program to improve safety, integrate ergonomics and minimize the cost of providing transitional duty for injured employees.
  - ii. How to use EAIP for every claim. Claims pie charts: cause of injury, cause for # TL days,
  - iii. Can use while claim is in deferred or accepted status.
  - iv. Wage Subsidy: 66 work days in 24 months, 45% of gross wages, can even include while somebody is on vacation, sick leave, and holiday. Can't get wage subsidy for OT hours if doctor limited hours.
  - v. EAIP: \$1000 for tuition/books/fees, \$400 for clothing, \$5000 for tools & equipment (includes worksite modification and job creation).
    - 1. Worksite mod: order during EAIP, reimbursable if purchased in good faith even if employee refuses to RTW or is released to full duty prior to receiving tool.
      - a. Property of employer, insurer determines appropriate worksite modification for worker.
  - vi. Example: maintenance employee with very weak thumb. Limits: 15# lifting/25# lifting. Purchased thermal imaging camera for \$5000 prior to Aubrey.
  - vii. Example: left arm strain. Limited use of arms, no knife assembly. Purchased touch screen computer to update safety data sheets.
  - viii. Example: thoracic upper back strain. No lifting over 10#, alternate sit/stand, occasional reach/push/pull. Assigned to custom laser machine. Purchased 3 in 1 stool. Modified station to be crank-height adjustable. Adjusted handle for door to reduce reach over shoulder.
  - ix. Example: de Quervain tenosynovitis. No repetitive use of right hand, no twisting use of screwdriver, limited twisting and squeezing w/right hand. Solution: automate process of using tiny screw driver, purchased torque driver \$3200, overhead mount. Raised surface for standing elbow height.
  - x. Example: humerus fracture. Limits: 4 hr shift, alternate sit/stand/walk, increase arm use up to <25# lifting. Needed to modify workstation for height and eliminate some tasks. Solutions: modified tables to be crank-height adjustable.
  - xi. Translated into experience rating modification reduction from 1.08 in 2011 to 0.89 in 2015.
  - xii. Now managers come seeking money from EAIP for projects.

- xiii. Purchased big Brady printer for secondary container labels for chemicals.

- xv. Question regarding the initial discussion with management to get support. Didn't initially have numbers. Had to build trust based on credibility and experience.
- xvi. Has a list of RTW jobs, projects and tools.
- xvii. Challenge of old job descriptions with higher physical demands. May need to update full duty job description to reduce demands.
- xviii. There are independent consultants that provide RTW support through TPAs for self-insureds.
